Message from Our Director

Beginning with the onset of the COVID-19 pandemic in 2020, Oregon, the country, and world entered a time of incredible stress. Oregon's healthcare community has been greatly impacted by the pandemic's cascading effects on healthcare systems, healthcare delivery, mental health, and more.

I'm proud of the efforts that the Oregon ECHO Network has made to help mitigate these stresses.

From its inception in 2017, Oregon ECHO Network has focused on growing a program that would connect and support Oregon clinicians. That directive came into even sharper focus in 2020. Starting with the COVID-19 ECHO for Oregon Clinicians, launched less than a week after Governor Kate Brown shut down Oregon in March 2020, Oregon ECHO Network has been a source of information and community for healthcare professionals around the state.

As our commitment has grown, so has our organization. In the Spring of 2018, we offered three programs. In the Fall of 2019, we offered six programs. This year, Fall 2022, Oregon ECHO Network is offering 15 programs with topics that range from Long COVID to behavioral health integration for pediatric practices.

Our audience has grown, too. We've expanded our programs to serve audiences including community health workers, skilled nursing facility staff, dental professionals, and recovery peer mentors, all while continuing to serve our core audience of Oregon's primary care clinicians.

We couldn't have experienced this type of growth without lots of help along the way. I would like to express my gratitude to OEN Clinical Advisor Dr. Jonathan Betlinski as well as Dr. Ron Stock, OEN's founding Clinical Advisor; our passionate staff; the Oregon Rural Practice-based Research Network, where OEN is housed; our Advisory Board; the dedicated professionals who serve as faculty for our ECHO programs; and of course, the close to 4,000 participants who have attended one or more of our ECHO programs.

As I look forward to the year ahead, I can easily envision it being busier than ever:

- The HRSA grant we received in late 2021 will seed new programming to serve the needs of rural and underserved Oregonians
- We will continue to focus on bringing health equity to the forefront for our organization, our programming, and the Oregon healthcare system
- We will continue to utilize the Project ECHO model to engage and inform new audiences

Letter from Our Clinical Advisor

"You're shorter than I thought..."

Since the first ECHO launched in Oregon in 2014, that phrase invariably pops up when I cross paths with ECHO colleagues. There's something about meeting together weekly to share knowledge, trade stories, and bounce ideas as we wrestle with systemic gaps in an effort to find better avenues to health for those who entrust their care to us that leads just as invariably to camaraderie and laughter.

While those words always give me a good chuckle—it's all a trick of camera angles, I promise — they also remind me just how often size has little correlation with impact. A small stone sends ripples across a windless alpine lake. A princess loses sleep over a wellpadded legume. A microscopic virus upends society for an entire planet. A small ECHO leads to a network strong enough to support 89 cohorts of 33 unique programs that not only directly benefit the 271 individuals whose cases are discussed, they also grow the expertise of 3,533 health care professionals who chose to invest themselves in a free exchange of knowledge in hopes of expanding access to healthcare here in Oregon.

What was once a part-time project manager, a fraction of an FTE of IT support, and 3 faculty has now become a team of nearly 20 staff, a passionate Advisory Board, and dozens of faculty across 30 different areas of expertise.

Where a few extra dollars once allowed the collation of self-reported practice changes and attendee satisfaction, we now have a HRSA grant that will help us better understand how care shifts for six rural Oregon counties when we develop ECHOs specifically for their residents.

And that's just our first five years here at Oregon ECHO Network!

So thank you! Thank you to Ron Stock, Maggie McLain McDonnell, and Nancy Elder for their persistence and leadership. Thank you to our Advisory Board and our Rural Advisory Panel for their support and guidance. Thank you to our brilliant staff for their creativity and hard work. Thank you to our faculty for their willingness and flexibility. Thank you to our attendees for their selflessness and determination to provide the best possible care for Oregonians. Thank you everyone for being a part of our ever-expanding community, and for helping us grow good health in our State.

WHO WE ARE

Launched in 2017, Oregon ECHO Network (OEN) is a statewide resource for Project ECHO® (Extension of Community Healthcare Outcomes), a telementoring program that connects participants with a specialist faculty team outside of their setting for case-based and collaborative learning sessions that take place in a virtual setting.

Oregon ECHO Network sessions include a practical, process-oriented expert presentation followed by discussion of a case brought by an ECHO participant. The case-based format promotes an "all-teach, all-learn" environment that is inclusive and interactive.

OEN supports a wide range of topics including substance use disorder, adult and child psychiatry, chronic pain, geriatric care, and integrating community health workers and recovery peer mentors into clinical settings.

A focus on healthy equity has been a key driver for OEN's philosophy and programming. Much work remains in addressing the health disparities among rural, aging, BIPOC, LGBTQ+, and other marginalized populations across Oregon. In the pursuit of eliminating health inequities, OEN is dedicated to embedding, maintaining, and regularly reviewing practices across all of our programs designed to decrease these disparities.



OUR HOSTING

Oregon ECHO Network is a project of the Oregon Rural Practice-Based Research Network (ORPRN),

ORPRN is a statewide network of primary care clinicians, community partners, and academicians dedicated to studying the delivery of health care, improving the health of Oregonians and reducing rural health disparities. With its focus on connecting clinicians serving rural and other underserved communities with specialist faculty for education and telementoring, Oregon ECHO Network aligns well with ORPRN's mission.

Since its start in 2002, it has completed more than 80 funded projects and is nationally recognized for expertise in practice facilitation and implementing patient-centered primary care home (PCPCH) practice redesign initiatives.

ORPRN is hosted by Oregon Health & Science University (OHSU), a public academic health center based in Portland, Oregon with clinics across Oregon and southwest Washington. OHSU strives for excellence in education, research and scholarship, clinical practice and community service. Through its dynamic interdisciplinary environment, OHSU stimulates the spirit of inquiry, initiative and cooperation among students, faculty and staff.




UNIQUE PARTICIPANTS SINCE 2018





OTHER SOURCES OF FUNDING

Heath Resources and Services Administration (HRSA) Grant

In the Summer of 2021, Oregon ECHO Network received a HRSA Grant for the Health Equity, Access and Quality Improvement Project Using Project ECHO in rural Oregon (HEAL-OR). The funding places special emphasis on six rural counties in Oregon (Hood River, Gilliam, Sherman, Wasco, Baker, and Umatilla).

To support the project, OEN developed a Rural Advisory Panel with representatives from each of the six counties who provide feedback and guidance on developing ECHO programs that best serve their population.

The 5-year HEAL-OR grant will support the delivery of 3 ECHO Programs per year.

The 12-session HEAL-OR Diabetes Care for Whole Person Heath ECHO launched in the Spring of 2022, the first HEAL-OR ECHO program funded by this grant.

Revamped to better serve the HEAL-OR mandate, this Diabetes Care ECHO offered topics like "Overcoming Barriers in a Rural Setting," "Nutrition and Patient Engagement in Latinx Communities," and "Structural Racism in Health Care."


OTHER SOURCES OF FUNDING

State Targeted Response to the Opioid Crisis Grants

Since 2017, the OHSU Addiction Medicine team has partnered with Oregon ECHO Network to provide ECHO programs focused on helping ambulatory care, hospital, and treatment facility teams care for patients with substance use disorder. These programs are funded by the Substance Abuse and Mental Health Service Association (SAMHSA) State Opioid Response grant program.

Over the years, Addiction Medicine offerings have grown to serve a variety of diverse settings as well as "Curbsides" programs, where ECHO graduates can share wisdom and community.

GROWING MINDFULLY

Pairing growth with a focus on our values led to a successful year

If we were to choose one adjective to describe 2021-2022 for our organization, it would be "dynamic."

Oregon ECHO Network hired new staff, launched new programs, and produced trainings for faculty. And we capped 2021 off by receiving a five-year, multimillion-dollar grant from HRSA that led to a number of initiatives, including the creation of a Rural Advisory Panel to better understand how our programs can meet the needs of Oregon healthcare professionals in rural settings.

New roles at OEN include a full-time Data Analyst, Maryan Carbuccia Abbott, who together with Evaluation and Data Manager Jean Hiebert Larson, are revamping our reports to provide a more accurate picture of our programs. Both were key personnel in creating this Annual report. The HRSA Grant, known as HEAL-OR, led OEN to hire former ORPRN director Nancy Elder, MD, MSPH, as Principal Investigator to lead HEAL-OR. HEAL-OR also led to the hiring of an additional Program Coordinator, Katherin Gomez-Arboleda.

Jonathan Betlinski, MD, also came aboard as Oregon ECHO Network's Clinical Advisor.

Amid all of this growth, we've continued focus on infusing equity into all that we do. This includes how we recruit and train faculty for our programs, the content of our programming, and outreach to develop new audiences.

In the Spring of 2022, we also debuted a video created by our Multimedia Specialist Brent Solheim that introduces Oregon ECHO Network and the work we do.

PROGRAM SATISFACTION



PROGRAM IMPACTS

Project ECHO was designed to be an amplifier for knowledge and skills with an impact that extends long after the video conference cameras are turned off.



PLANNED TO MAKE CHANGES

When asked in the post program survey, in 70% of the responses, participants reported that they planned to make changes in their practices as a result of the ECHO session.

PROVIDED CASE CONSULTATIONS

Aside from improving their own skills, ECHO participants share the knowledge they gain with other clinicians and clinic staff. Across all programs that asked this question, 56.4% of respondents to the post-program survey said they provided a case consultation with a colleague about a patient or had a discussion with clinic leadership on the ECHO.

CASE PRESENTATIONS

Case presentations are the heart of any ECHO session.

Participants bring their toughest cases or systems challenges to discuss with their peers and the multidisciplinary specialist faculty. Case presenters, other participants, and faculty all learn from each other, and the presenter comes away with a set of actionable recommendations.

COMMITMENT TO EQUITY

For 2021-22, OEN recommitted to promoting health equity in our organization and our programs

Developed in 2020, Oregon ECHO Network's Diversity Statement reads, "As a project within the Oregon Rural Practice Based Research Network, Oregon ECHO Network is committed to building and sustaining a diverse, equitable, inclusive and anti-racist organization. We do so by evaluating how we develop and support our workforce, the partnerships we uphold and how we engage in community-partnered dialogue, research, coaching, and education throughout Oregon."



We have made progress toward that goal by networking within the community to develop faculty from diverse geographical locations, institutions of employment, racial and ethnic backgrounds, and other relevant lived experience. Before any new program launches, the Project Developer facilitates discussion with faculty on how they plan to consider a health equity lens when developing their presentations.

Oregon ECHO Network held its first **Health Equity Training Workshop** on October 29, 2021. Bahia Overton, the Executive Director of the Black Parent Initiative, and Holly Hofkamp, MD at Providence, facilitated the workshop highlighting various types of bias and their impacts, as well as ways to identify health inequity, implement changes, and evaluate the changes that are made.

ECHO FACULTY


Each ECHO program has a faculty team of three to five subject experts with a broad mix of credentials. Faculty are recruited from state and local health departments, academic medicine faculty, external organizations, and patient advocate groups, creating a 360-degree view of the subject. Facilitators work to bring all faculty into the conversation with respect, which serves to break down hierarchies and model equitablity.

A LOOK AHEAD

Although the pace of our organization's growth has been rapid, the hunger for education and community among the Oregon healthcare workforce, the creativity of our management team in developing and funding new programs, and the value of the Project ECHO model all point toward continued robust growth in the next year. Some ways this growth will be achieved include:

New audiences

• Fall 2022's Substance Use Disorder in Jails ECHO is a great example of the ways in which OEN can support faculty to share their expertise in subjects like SUD to bring knowledge, confidence, and community to non-healthcare settings.

Behavioral health

 Behavioral health integration continues to be a cornerstone of efforts to reduce chronic disease and increase well-being across the state. OEN will build on its successful Integrated Behavioral Health for Pediatric Populations ECHO to create the new Integrated Behavioral Health for Adult Populations ECHO.

Partnering with public health

 We learned through COVID-19 the importance of working collaboratively with public health. We are proud to continue these connections by including public health leaders on our HEAL-OR Rural Advisory Panel and developing a Public Health Preceptor ECHO focused on providing support to public health professionals seeking to mentor student learners.

Tailoring programs to better address health disparities

 The HEAL-OR grant has provided an important opportunity to focus three ECHO programs on the needs and health concerns of older adults. Latino populations, and medically underserved communities. We will take these learnings and apply them across our ECHO programs.




